DOH WELCOMES DR. JOSEPHINE SHENOUDA

On March 13, 2023, **Josephine Shenouda** joined the DOH as the new **Early Intervention Director**. Previously with Rutgers University for 12 years as a co-Investigator on the CDC Autism and Developmental Disabilities Monitoring (ADDM) Network for New Jersey, Josephine holds a Master of Science in Biomedical Sciences from Rutgers Graduate School of Biomedical Science and a DrPH in

Epidemiology from Rutgers School of Public Health. In 2020, she joined the Rutgers School of Public Health faculty as an Adjunct Professor of Biostatistics and Epidemiology teaching Principles and Methods of Epidemiology and Evaluation of Public Health Surveillance. Her research has focused on developing evidence-based strategies for ASD interventions, addressing health disparities in ASD identification and intervention and has recently been published in JAMA Pediatrics and Pediatrics.

During her tenure with Rutgers Josephine and the DOH-EIS team collaborated frequently in support of the ADDM Network and other research and activities related to early intervention.

Over the next few weeks, the DOH team will be supporting her transition to the role of Director by introducing her to NJEIS stakeholders, reviewing the strengths and initiatives currently in motion in NJEIS, along with the areas of critical need and opportunities.
